Commercial Exhibitor Rules and Regulations:

- 1. Fill Out the Wisconsin Temporary Event Operator and Seller Information Form completely and return with this application.**
2. The commercial building will be open on Tuesday, July 24<sup>th</sup> from 10:00 AM to 9:00 PM to allow exhibitors time for setting up their booth for the start of the fair on July 25<sup>th</sup> at 10:00 AM. **Any tenting or canvas must have a fireproof seal.**
3. The commercial building will be open on Wednesday, Thursday, Friday, and Saturday from 10:00 AM to 10:00 PM and on Sunday, July 29<sup>st</sup> from 10:00 AM to 5:00 PM. It is expected that you have someone in your booth while the commercial building is open.
4. Exhibitors will be responsible for maintaining their space in a neat and clean condition. All exhibitors must have their area cleaned out and items removed from the Dunn County Fair Grounds and the Commercial Building no later than 5:00 P.M. on Monday, July 30, 2012. The Dunn County Fair Board will charge exhibitors for a cleanup of their area and items left, after 5:00 P.M. on July 30, 2012. The cleanup charge will be \$150.00 minimum or actual cost for cleanup of your area with no liability for the items removed or destroyed.
5. Exhibitors will be responsible for their own merchandise and will provide security for their own merchandise, if necessary. The Commercial Building is closed nightly at 10:00 PM and opened at 7:00 AM the next day. The commercial area will be roped off.
6. The exhibitor will provide ample liability insurance to compensate for any loss or damage that may occur from his/her negligence. The exhibitor agrees to indemnify, release and hold harmless, the Dunn County Board, Dunn County Fair Board their personal and entities for any and all claims and/or damages arising from the use of the premises and/or your negligence.
